I understand that by signing this agreement, myself, and my guests are responsible for any and all damages to the center, and pool. By signing this agreement, I, also relieve The City of Martins Ferry of any and all responsibility and liability of injury and / or loss which may occur.

There will be certified lifeguards provided, a minimum of 3 per 50 guests. Renter will NOT have access to any of the other rooms in the Rec Center, including the gymnasium.

Dining Room and access to pool for guests ONLY, 50 people maximum, parties will be held on Saturdays ONLY after regular pool hours: 6:00pm until 9:00pm.

\$350.00/3 hour rental

Deposit of \$175.00 is due at time of contract signing. Balance MUST be paid in full, NO LATER THAN ONE WEEK prior to rental. If cancelled 2 weeks prior to rental, you will ONLY receive \$50.00 of the deposit back.

I agree to be respectful to the pool and recreation center. I agree to dispose of any and all trash and dispose of properly, in the dumpster outside the Rec center. I agree to leave the pool area and locker rooms in the same or better condition when they were rented.
